

2018 Holiday Market

Nov. 17 Rosemary Beach, FL

Dear vendors:

It is time once again to make your plans to be a part of the annual Rosemary Beach Holiday Market. Now in it's 16th year, the event will be making a few changes to better the community of Rosemary Beach and the vendors who take part in the event.

For the past 15 years, the event has always been held on the Saturday following Thanksgiving. It was always to get the early Christmas shopping in, and has become a staple of holiday markets on the Emerald Coast.

After meeting with the various merchants, home owners, and hearing from the Rosemary Beach Property Owners, the market will be moved one week earlier, to the Saturday prior to Thanksgiving which is Nov. 17. The Rosemary Beach community wanted to move the date to the week prior to Thanksgiving, for three reasons.

- 1) There was too much activitity taking place the weekend after Thanksgiving and those wanting to attend the market, did not have enough time to browse and shop. Also some of the events from the previous year, are being eliminated for 2018.
- 2) Parking has always been an issue at Rosemary Beach, no matter what weekend. But the market created havoc with not only security, the merchants, and those trying to find a place to park to attend the event, but the county has not been kind to the property because of the various parking issues and traffic congestion on Cty. Rd. 30A.
- 3) Cross promotion by both Hilltop Production Events and Rosemary Beach, will increase due to the fact that the Holiday Market will be the sole event that weekend. If you were wondering about crowds, foot traffic and resort capacity, it is even greater the weekend before Thanksgiving.

For the first time in the market's history, 20% of all vendor fees will be given back to the Rosemary Beach Foundation. This organization gives funds to those in need, and helps better the Emerald Coast and its citizens.

Once again we will be set up on the Eastern Green and Western Green, with 40 vendors on each green. There will also once again be platinum spaces available and those are listed on the attached layout of the green.

- Vendor must be able to set-up in designated, paid space
- All spaces are 12 x 12 except for spaces #1, #2, #3 and #4
- All spaces located on the Eastern Green and Western Green
- YOU BRING IT IN-YOU TAKE IT OUT!!! REMOVE ALL TRASH
- Each vendor is responsible for their own sales tax (Walton County is 7%)

- Parking is for loading and unloading ONLY!! NO OVERNIGHT PARKING
- All vendors must vacate property by 7 p.m.
